- 1. Standard terms of payment are strictly nett 30 days following month of invoice.
2. It is understood that any goods supplied are the property of Power Plant Hire Ltd. until such time as settlement is received in full for any goods outstanding.
3. In the event of non payment within our contract term, interest is payable at the rate of 2% per month from the due date to the date of payment and in the event of the issue of legal proceedings for recovery of any outstanding amount, a collection charge of £50.00/£100.00 (£50.00 for a debt up to £600.00 and £100.00 for a debt over £600.00) is payable by the customer and will be added to the debt outstanding in any such proceedings.
4. It is understood that any contract between Power Plant Hire Ltd. and myself/ourselves shall be governed by and construed in accordance with English Law and that Power Plant Hire Ltd. and myself/ourselves hereby irrevocably submit to the non-exclusive jurisdiction of the English courts.
5. Save where such terms are inconsistent with terms 1 to 4 above, any contract entered into will be subject to the Model Conditions for the hiring of plant (a copy of which I acknowledge having received).
